- a. Cash Flow Report and Revenue through October/November 2020; Presented by Ms. Padilla, also presents enrollment/average daily attendance.
 - Board Member Benavidez asks when the \$20,000 that preschool borrowed will be paid back. Ms Padilla says it has to be paid back by the end of June 2021
 - Comment from public; Mrs. Johnson said attendance was down, 94% seems high. Mrs. Johnson specifies attendance on Google meets is low, but the work is still getting turned in and that also counts for attendance.
- b. Maintenance and Operations; Presented by Mr Elizondo.
 - Day to day disinfecting of site
 - Cleaning, trimming and mowing of the grass areas
 - Installation of the sprinkler systems
 - Handing out food and work packets on Monday with cafeteria and teachers
 - About 100 or so plastic dividers have been ordered.

 Board Member Benavidez asks how often disinfecting is happening. It is happening daily. Her concern is if students are coming on campus consecutively, are they disinfecting between visits? Roy says that all the teachers have wipes, hand sanitizer and everything they would need to use to disinfect the area. Mrs. Johnson says that they have the students that leave and come in practice disinfecting and washing their hands. Teaching responsibility to her kids to clean up their areas. The wipes they are using have been provided by the county. They are not Clorox wipes.

 - Meal service time has changed from 8am to 10am.
 - Seamless summer is still in effect. 18 and under can get meals

- d. Technology Report; Randy Randolph
 - Doing our best to keep up with the demands
 - Acquired more hotspots, families with multiple students have received 2 hot spots.
 - Now have a chrome book for every student
 - Upgrading our phone systems on campus over Winter Break. Hopefully to solve connectivity issues.
 - Upgraded wifi about a year ago and we submitted a grant and received it this month. \$60,000.
