Comment from parent: Any updates on Covid testing for Teachers? Mr. Vigil says that he reached out to three different companies, two said that they would not be able to come on site, since the 20-minute testing option would have to be on their site.

Comment from parent: regarding the Zoom meeting for ELAC, what was the discussion? Mr. Vigil was the Spanish Speaker. The meeting was not recorded. They made a decision on President, Vice President and Secretary for ELAC. Went over the LCP, talked about the Con Ap, went over the services to EL families and talked about parent support for all parents to learn technology.

# Superintendent, R-G Vigil;

- Survey went out to parents regarding if our current school schedule is working for them; 54% Yes it works, 22% sometimes works, 14% does not work. Has the school reached out to contact you; 69% Said yes, 22% Sometimes, 9% said No. Which online instruction would you prefer; 39% said recorded, 61% said live instruction.
- Posting this information on the website for people to view. ELAC meeting happened on Thursday, in English and Spanish.

#### West Park Elementary, R-G Vigil;

- Parent Zoom meeting was today followed by a staff Zoom Meeting. Today marks the
  beginning of spirit week. We are applying for the state waiver to have students back
  on site and tabling it until it is time to move in that direction after board approval.
- Assessments for students will happen in October and November on a small scale.
- Continuing to outreach to students through optional home visits.
- Red Ribbon week October 26, 2020. Century Book Club starting October 19, 2020, an incentive to get kids to read more.
- We have received new copiers and training for them will be this week.
- October 5-9 is Fall Break and staff PD days will be on October 7 and October 8. Second Quarter starts October 12, 2020.
- Every other Monday starting today FCSS Migrant Program will be on site passing
  out food to our community from noon to two PM. Today they ran out of food at 1PM.
  Board Member Vivenzi requests that if they do run out of food that an additional
  parent square be sent out to let the community know.

- Board Member Vivenzi wants the public to know her priority is the best interest of
  this District and when she asks for more time to review things it is because she has
  already seen things she has not agreed with and she wants time to cross check before
  approving anything.
- Public Comment: Did the survey results include Charter? No just elementary. Mr. Elizondo said he will bring results for the Charter side to the next board meeting.
- Public Comment: If I need to get ahold of Ms. Diaz should I direct my questions towards Mr. Vigil? Yes, direct them to Mr. Vigil.
- Public Comment: Where will the polls be? Usually it is in our library, Mr. Vigil will reach out to find locations.

#### West Park Charter Academy, R. Elizondo;

- Self-vetting is still happening at each sites and before coming on sites.
- Renaissance training will be on October 12, 2020. October 23 is Red Ribbon Week, where they will be doing an essay and poster contest. November 5 is the Charter ELAC via Zoom.
- Mr. Elizondo presents a brief PowerPoint on WPCA Grade analysis for the last 3 Grading Periods. He will bring the report back in November board meeting for an update with final grades after quarter closes. Current enrollment is 294 in comparison to 2019/2020 Fall was 274.
- Public Comment: Is there any more information on Board Candidates other than what Mr. Vigil gave out during the parent Zoom Meeting? Mr. Vigil says there are currently 2 open seats, 1 four-year term and 1 2-year term. 4 people are running for the four-year term.
- After researching, we are unable to post anything on school property but to refer people to the elections office.
- If someone wants to run they do not need to contact the school first, just go to the elections office.
- If it is an appointment then they would check in to the District Office, but to be put on the ballot they would need to contact the elections office.
- Public Comment: We have teachers and paras missing this semester. Mr. Elizondo says We have some on Covid19 leave and we were unable to fill some positions as well.
