The Board asks if the Board will be notified if a transfer takes place. Mr. Vigil answers, yes, whenever transfers happen they need to be board approved. Public Comment from Mrs. Vivenzi; if the budget was correct would we need this resolution? Mrs Padilla answers; We have to have this resolution on file with the County if we need to do transfers.
